Automated volume licensing control for large enterprises using the Adobe Provisioning Tool for Windows^{*} or the Apple Remote Deployment Tool for Mac OS eliminates the need for manual installations. Acrobat X also supports centralized server hosting using standard hosting environments such as Citrix Presentation Server or Windows Terminal Services. The Adobe Customization Wizard, a free downloadable utility, helps you customize the Acrobat installer and configure application features before deployment.

The ability to create dynamic, interactive Adobe PDF files with Acrobat X helps your workforce accelerate collaboration and drive new, more effective communications inside and outside the company. AEP participation criteria

Special AEP pricing is available to commercial organizations in the United States and Canada that agree to 100% Acrobat X coverage for all desktops within a defined business entity, such as a company, business unit, or division, of at least 1,000 desktops. Organizations must sign a three-year Adobe ELA and agree to ELA terms and conditions. This program is not available under the Adobe Cumulative Licensing Program (CLP) or Transactional Licensing Program (TLP).
